## ETHICS AND LIFESTYLE CODE

Winkler Bible Camp has adopted an *Ethics and Lifestyle Code*. It is as follows:

To conduct myself at all times during my stay at camp in accordance with my Christian conviction and standards as are set forth by Winkler Bible Camp.

- A. I will respect the authority of the organization's leadership staff, demonstrating a willingness to serve and be directed by others.
- B. I will always avoid situations with others which could, in any way, be misconstrued as inappropriate.
- C. I will refrain from sexual relations of any kind outside of the marriage relationship.
- D. I will honor the laws of this country, understanding that government is placed in authority over me by God, appreciating that breaking the law can jeopardize the safety of myself and others, and damage the reputation of this ministry in the community.
- E. I understand that total abstinence from alcohol while I am a student at Cross Current is required and realize that consuming alcohol in public or private or public drunkenness constitutes grounds for dismissal.
- F. I will abstain from the use of tobacco products.
- G. I will abstain from the use of illegal, non-prescription drugs.

# WAIVERS AND CONDITIONS OF ENROLLMENT

1. The Camp Director and Cross Current Director reserve the right to dismiss a student who is in his/her opinion a hazard to the safety and the rights of others, or who appears to have rejected the reasonable guidelines set for student conduct (see Ethics and Lifestyle Code). In such event, the student is responsible for any travel expenses that may result from the dismissal. The student certifies that they are normal in condition and habits and are amenable to necessary discipline.
2. While every precaution is taken for the safety and good health of our students, Winkler Bible Camp, its directors, other staff members and other employees of facilities outside of the camp grounds are hereby released from any liability in the event of an illness, accident or misfortune that may occur to the applicant student. Each student must be insured by Provincial Health or equivalent medical insurance. Each student is responsible to have adequate travel insurance for the mission trips.
3. The signature of the applicant/parent/guardian on this application shall give the Camp Director or Cross Current Director the right to arrange for any special service or other requirements necessary for the best interests of the applicant and shall give the Camp Director or Cross Current Director the right to approve and obtain medical attention necessary for the applicants welfare and good health including injections, anesthesia or surgery. In such situations the camp will attempt to notify the emergency contact as soon as possible. The applicant/parent/guardian is responsible for any additional expenses that may result from such services.
4. The signature of the applicant/parent/guardian on this application shall authorize the appropriate police force to make any investigation of its records and enquiries of other police forces, which may be relevant to this applicant's involvement in camp functions.
5. The signature of the applicant/parent/guardian on this application shall give the camp permission to use pictures or video of the applicant for promotional purposes.
